

Indian Coast Guard inks MoU with private sector for indigenous marine grade steel to enhance indigenous content in shipbuilding

- Indian Coast Guard (ICG) and Jindal Steel & Power (JSP), signed a Memorandum Understanding for the supply of indigenous marine grade steel to enhance the indigenous content in shipbuilding.
- Through this partnership, both entities have foster indigenisation, enhance committed to capabilities to produce and use these items in the Nation's interest.
- The MoU underscores the importance of publicprivate partnerships in addressing complex security challenges, emphasising the need for collaboration between government agencies and the private sector.

Kerala filmmaker Sangeeth Sivan dies at 61

- Film director Sangeeth Sivan passed away in Mumbai. He was 61-year-old.
- Sangeeth's maiden directorial venture was Malayalam action thriller 'Vyooham', released in 1990.
- He has directed around 20 films in Malayalam and Hindi.
- 'Yoddha', 'Gandharvam' and 'Nirnayam' were among the noted Malayalam films helmed by him. 'Johny', released in 1993, won the state award for best children's film.
- The Mohanlal-starrer 'Yoddha' was an all-time hit and is considered his most popular work in Malayalam. The film paved the way for music composer A R Rahman's entry into Malayalam.
- His directorial debut in Hindi was 'Zor' with Sunny Deol in the lead. His other notable films in Hindi were 'Sandhya', 'Chura Liyaa Hai Tumne', 'Kya Kool Hain Hum', 'Apna Sapna Money Money', 'Ek: The Power of One', 'Click', and 'Yamla Pagla Deewana'.

South Korea agrees with Indonesia on KF-21 fighter jet project

- South Korea is closely communicating with Indonesia regarding its adjusted proposal to reduce cost-sharing for the KF-21 fighter jet programme.
- Indonesia has recently suggested to the Seoul government to cut its share of payment and pay about 600 billion won (US\$442.3 million) in total for the KF-21 jet project by 2026, a decrease from the initial 1.6 trillion won.
- In 2016, Indonesia had agreed to pay 20 per cent of the total development cost of 8.1 trillion won, in return for receiving one prototype model and technology transfers that would allow it to produce 48 units in Indonesia.
- Recently, Seoul's state procurement agency hinted at accepting Indonesia's proposal, saying that it will finalise its decision as early as not to cause delays in the development project.

US automotive firm BorgWarner launches **R&D** centre in South Korea

- U.S. automotive company BorgWarner has opened a research and development center in Korea, which is expected to help stabilize the supply chain in the sector.
- The new center, located in Daegu, will focus on developing integrated driving modules automobiles with a combined investment of \$43.6 million through 2027.
- BorgWarner currently operates seven production lines across Korea, employing around workers.
- The company pledged to open the center on the margins of President Yoon Suk Yeol's visit to the U.S. in 2022.
- The new center, employing 43 experts, is expected to enhance the competitiveness of the local automobile industry and help stabilize the supply chain as well. www.race4job.com














RBI lifts ban on Bank of Baroda's BoB World

- The Reserve Bank of India lifted the restriction on Bank of Baroda (BoB) that barred the public sector lender from onboarding customers through its mobile banking application 'bob World'.
- The ban on bob World was imposed after the RBI found lapses in the process followed by the lender in onboarding customers through the mobile app.
- It was alleged that a few employees of the bank's Bhopal zonal office linked some bank accounts to the mobile numbers of different people and registered them on the mobile app, primarily to increase the registration numbers on bob World.
